All vendors must display only within their allotted space. You understand that you must bring table and table covers, as well as, canopy if your are under your 10' x 10' space. No early breakdowns are permitted. You will receive notification in May to be included in publicity and will receive a marketing packet to contribution in promotion of this creative and community event.

A signed and completed Hold Harmless Agreement is required. Please include it with your application. Business Insurance is highly recommended.
